# U.S. Ocean Climate Action Plan **Comments by the Florida Ocean Alliance**

## **Background**

The Florida Ocean Alliance (FOA) is pleased to respond to the request for information on the U.S. Ocean Climate Action Plan (OCAP) from the Office of Science and Technology Policy (OSTP). The Alliance represents a "community of practice" in Florida, a 501c(3) nonprofit organization that is a diverse nonpartisan leadership partnership dedicated to positioning Florida as a global leader in responsible ocean and coastal economic development, conservation, education, and technology innovation. Our Board of Directors represents the private sector, including representatives from ocean-related industries in tourism, ports, shipping, cruising, recreational and commercial fishing, and recreational boating, as well as representatives from nonprofit research organizations, academia, the ocean research community, and public interest groups. In June of 2020, the Alliance completed a Strategic Plan for Florida's Oceans and Coasts that was funded by the Florida Legislature. This Plan (2020 Strategic Plan "Securing Florida's Blue Economy: A Strategic Plan for Florida's Oceans and Coasts") highlighted four key issues: (1) the Blue Economy, (2) Ocean and coastal resilience, (3) Human and natural infrastructure, and (4) Implementation, outreach and financing.

### **Critical Actions**

Florida is an ocean state with lengthy and multiple coastlines and an invaluable marine environment accessible to all residents. It should be viewed as one state that borders both the Atlantic and Gulf of Mexico coasts, as well as encompassing the Everglades. Therefore, the development of a national Ocean Climate Action Plan is of high importance to our state. Resilience is critical here -- "ground 0" -- as we deal with increasingly stronger storms and hurricanes, as well as warming oceans and accelerated sea level rise along our coasts.
